## HOUSING SUBSCRIPTION MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) expresses the guidelines by which Eden I&R, Inc. grants use of information from its Housing Database to the agency listed below (Agency) through a subscription. The agreement and access to the information shall remain in place for a period of one year from the date signed. In signing this MOU both parties agree to the following terms:

- **Access and Use Rights.** 2-1-1 Alameda County grants personal and limited rights to access and use the resource guide for personal and non-commercial use. You may make personal, non-commercial use of the materials only and only for the purpose for which they are provided or made available to you, but you may not make any commercial use, including without limitation reselling them, charging to access them, charging to redistribute them, or charging for derivative works based on them. Eden I&R expressly retains all ownership rights, title and interest in and to all aspects of the resource guide. These rights shall not be construed or interpreted as granting or providing rights to you to use, reproduce, modify, distribute, perform, display, possess or control the data, content, or any other aspect of the resource guide.
- Eden I&R, Inc. will provide biweekly updates of available housing either through a hard copy printout, or an electronic copy (PDF file) via email which ever medium is selected by Agency.
- Agency will pre-pay for one full year at the rate appropriate for the agency as listed in Attachment 1. No refunds available for early termination of subscription.
- Agency must dispose of previous listing when new listing is received.
- Listings will consist of information which has been updated within the last two weeks of the publication date. For daily updates, clients should call Eden I&R 's 2-1-1 Information and Referral Line at (510) 727-9560, available 24 hours a day.
- Agency will not duplicate information for distribution to other agencies or other locations. If Agency would like additional copies of the listings, Agency must purchase the additional copies or licenses from Eden I&R.
- Agency will not share their PDF file or hard copy with other agencies or locations.
